# APPROVE AN AGREEMENT WITH THE WHITE TOWNSHIP EDUCATION ASSOCIATION

A motion was made by Mrs. Lensi and seconded by Mrs. Nikolopoulos to approve an agreement between White Township Board of Education and White Township Education Association for the period July 1, 2015 to June 30, 2018 and authorize the Business Administrator to pay employees of the district at the 2016-2017 negotiated salaries based on the negotiated 3 year agreement salary guides and pay retro monies for the period July 1, 2015 through December 31, 2016. ### **OPEN PUBLIC COMMENT**

Mrs. Heller asked about changing the format in the district from a shared service for Superintendent to a different model. Mrs. Heller noted she recalled that the shared service committee was meeting and wondered if members had received minutes from the committee meeting. Members noted that the Committee meeting was held right before the last Board meeting, so while there were no minutes shared, the Chairperson of that Committee had reported to the Board that the shared agreement for Superintendent and Business Administrator was working well for both districts. Mrs. Heller noted that a neighboring district is working with a CSA and Vice Principal model and they are an exemplary team that is working very well for their district and, wondered why our district wasn't considering this. The Board noted discontinuing the share was not discussed at the recent Committee meeting. Mrs. Heller further noted that she has reviewed the districts per pupil legal fees and wondered why they are so high compared to other districts in the County. Mr. Boehm encouraged Mrs. Heller to email him with any other questions or concerns she has.
